Self-contained breathing apparatus and protective clothing should be worn when fighting large fires involving chemicals. Avoid skin / eye contact; do not breathe fumes. Prevent fire-control run-off from entering streams or drinking-water supply.

Absorb with an inert absorbent (sand, sawdust). Scrape up and place in an appropriate closed container. Do not flush to drain.
